Martha's Vineyard Bank Charitable Foundation Announces Community Impact Grants Recipients

Falmouth, MA – Martha's Vineyard Bank Charitable Foundation announced today that Friends of Nobska Light and The 300 Committee Land Trust were the two Community Impact Grant recipients in Falmouth, and Media Voices for Children was the Community Impact Grant recipient on Martha's Vineyard. Each of the non-profit recipients received a \$2,500 grant for a total of \$7,500 in grant funds.

The announcement of the Community Impact Grant award recipients came last night at the first "Business After Hours" event since 2019 that the Bank hosted in conjunction with the Falmouth Chamber of Commerce as part of the Grand Opening celebration week at the Bank's newest location on the Falmouth Village Green at 84 Main Street. Two grants were awarded in Falmouth to commemorate the Grand Opening of the new Village Green location.

Annually, Martha's Vineyard Bank Charitable Foundation invites the community to submit nominations for a non-profit organization that made a significant impact in Falmouth and on Martha's Vineyard the previous year.

Award recipients were selected from 52 nominated and eligible entries of 501c3 non-profits on Martha's Vineyard and in Falmouth. There were over 5,000 votes, an increase of nearly 200% over our 2020, the first year of the Community Impact Grant Program.
